9. Open Session (Public Forum)

Questions & representations from parishioners relating to reports or business to be conducted on this agenda or regarding other matters which they wish to bring to Council's attention.

This is a 15 minute session where any member of the public may speak for up to three minutes.

It provides an opportunity for members of the public (who are not usually permitted to speak during the council meeting, other than by special invitation of the Chair to participate before the meeting by asking questions, highlighting matters of concern or making

representations regarding Kilmington Parish. No decisions can be taken on matters raised during this part of the meeting unless the subject is already an item on the published agenda.

A number of parishioners raised their concerns about the potholes and ridges which are on both the tarmacked section and the untarmacked section of the Roman Road. DCC Cllr. Chubb firstly explained to them that the tarmacked section was a classified highway and as such was the responsibility of Devon Highways whereas the untarmacked section was a bridleway which was a Public Right of way and the responsibility of Devon Public Rights of Way (PROW) dept. who deal with footpaths and bidleways.

Cllr. Ball said that the Parish council would speak to officers in both departments about the parishioners concerns and ask them to inspect both sections of the Roman Road.

Parishioners also raised the matter of the Public Spaces Protection Orders (PSPO)that had recently been imposed by EDDC on the recreation fields and the playground. A petition had also been submitted to the Parish Council requesting that the Parish Council reconsider this matter. Cllr. Ball explained to the parishioners that the Kilmington Playing Fields is not owned by or the responsibility of the Parish Council. It is owned and managed by the Arthur Hitchcock Trust and that parishioners should speak to the Trustees of the Charity who manage the area about the Public Places Protection Order (PSPO) requiring dogs to be kept on leads within the recreational playing fields. He said that Mr Michael Collier, the Chair of the trustees was due to give a report at the following Annual Parish meeting and they should address their concerns to him.

The Clerk said that the only area that the Parish Council owned and was responsible for within the recreational playing fields was the fenced Childrens playground. This had a separate PSPO order in place banning dogs from inside the playground. This had been requested due to persons ignoring the No dogs signs, taking dogs inside the fenced playground and allowing them to defecate on the grass and the rubber safety matting and not picking up.

10. Minutes of the Meeting held on 3rd April 2023

The minutes were declared a true record of the proceedings, proposed by Cllr. Jones, seconded by Cllr. Seward, all in favour.

EDDC Cllr. Chubb advised that he had been a District Councillor for 16 years and had just been re-elected for a further 4 year term of office. Following the elections, council meetings were now being held to determine the membership of the various Committees and the roles/responsibilities of the Councillors.

As a DCC Councillor his area of responsibility covered 23 Parish Councils. The main common topic raised by the these parish councils was Highways matters and in particular potholes, the highways criteria for determining whether a pothole needed repairing, the delays in the repairs being carried out and the standard of the repair work carried out. The Devon Highways budget was the second highest within the County Council budgets due to it's county wide highways network being one of the largest in the network. Even with this high budget the size of the network placed

constraints on the extent and nature of the work which could be carried out by Devon Highways and this was the reason for the pothole criteria in order that the available funding for repair work could be directed to the worst potholes across the network. He advised parishioners to continue to report potholes and other highways concerns to Devon Highways via the online highways problem reporting portal. This portal can also be used to report hazards and problems on Public Rights of Way which includes byways and footpaths.

He said that he would speak to the Highways officer regarding the matters raised by parishioners in the earlier open session and ask what can be done in relation to these matters.

a) Current Financial Position

c) Asset Register Review

The Clerk advised that Cllrs Ball & Seward had reviewed the asset register and had also established that the Parish Council did own the War Memorial. Reference to the Council minutes of the 1920's showed that the Parish Council had formally adopted the War Memorial. It has now been added to the asset register and a an amended asset register drawn up based on the review.

d) Renewal of Council Insurance

The Clerk reported that the Insurance brokers had recommended renewal with the existing insurer and advised that the renewal premium is £1,386.56. Cllr. Jones proposed renewal of the policy and payment, seconded by Cllr. Seward, all in favour.

The Clerk advised that the asset register review had also included a review of the asset sums insured and that these would be dealt with by endorsement at an additional premium.
